		Mackinac County – D. Heckman requested an approval of a minor change on the FY 2024 Cheeseman Road in Major Work Type from Ultra-Thin Asphalt Overlay to One Course Asphalt Overlay and that all available State D funds be allocated. The 1799 Form was given to RPA and the numbers were reflected in the spreadsheet. There should be some cost savings coming from 2023 Job which may affect the numbers and would like to ensure that it is all used towards this job, because if there is a discrepancy from the way that it is programmed in JobNet it may affect what is available. B. Stark said actual numbers should be out in early December. MOTION TO APPROVE THE REQUEST FROM MACKINAC COUNTY AS STATED ABOVE WAS MADE BY R. Laitinen; SUPPORTED BY P. Paramski. MOTION WAS APPROVED UNANIMOUSLY. Luce County – M. McTiver reported the Luce Co. allocation had a little more than \$250,000 available and could use more on CR 407. In addition, he would like to move up a County-wide Pavement Marking job for \$90,000 from the Illustrative List to FY 2024. With increasing prices on vehicles an additional \$10,000 could be used on EUPTA's van purchase.		

	MOTION TO APPROVE A COST INCREASE ON FY 2024 JOB #214797 CR407 TO STBG FEDERAL FUNDS OF \$362,400 WITH A LOCAL MATCH OF \$62,600 AND STATE D FUNDS REMAINING THE SAME AT \$28,000 FOR A TOTAL JOB COST OF \$453,000; A LUCE COUNTY-WIDE PAVEMENT MARKING JOB TO BE MOVED TO FY 2024 FROM THE ILLUSTRATIVE LIST IN THE AMOUNT OF \$90,000; AND AN INCREASE IN COST OF STBG FEDERAL FUNDS OF \$10,000 TO EUPTA VAN PURCHASE ALLOCATION MADE BY D. They will be working on Mackinac Trail which includes funds from Small
	Urban Program as well.
